GIFTS THAT PAY YOU

Charitable Gift Annuity

- Make a onetime gift to AMG
- Receive fixed income for life
- Avoid capital gains tax on appreciated assets
- Provides an immediate tax deduction
- Future income is partially tax free
- Income can be paid to you or a loved one
- Income can be transferred to a secondary beneficiary upon death
- High rate of return based on beneficiary's age:

AGE	ESTIMATED RETURN
60	3.2%
70	4.0%
80	5.5%
90	8.0%

Charitable Remainder Trust

- Make a onetime gift to AMG
- Receive income for life or fixed period
- Income can be fixed or based on the value of the assets
- Avoid capital gains tax on appreciated assets
- Provides tax free growth of assets
- Provides an immediate tax deduction
- Income can be transferred to a secondary beneficiary upon death

GIFTS FOR TODAY

Life Estate

- Make a onetime donation of your residence or other real estate to AMG
- Maintain the use for your lifetime
- Provides an immediate tax deduction for the fair market value
- Avoid any capital gains on appreciated property
- Removes property from your estate and probate

Securities

- Make a onetime donation of your appreciated securities to AMG
- Provides an immediate tax deduction for the fair market value
- Avoid any capital gains tax on appreciated property
- Reduces potential estate taxes

Cash

- The easiest and fastest way to make a donation
- Gifts can be made with checks, credit cards, PayPal or bank drafts.
- Gifts can be set up as one time or recurring
- Provides an immediate tax deduction

FINAL GIFTS

Wills & Bequests

- A final gift can be made to AMG through your will
- Gifts can be a fixed dollar, a percentage of the assets or a specific asset
- Gifts can include bank accounts, investment accounts, residential property, business interests or other assets
- Assets remain available and accessible during lifetime if needed

Retirement

- Designate AMG as the beneficiary on your IRA, 401(k), 403(b) or pension
- Gifts can be a fixed dollar amount or a percentage of the value
- Assets intended to provide during your lifetime become available for gifting
- Removes property from your estate and probate

Life Insurance

- Designate AMG as the beneficiary on your life insurance policy
- As your children become financially independent, policies intended to provide for them may no longer be needed
- Removes proceeds from your estate and probate
